- 1) **Call Meeting to Order/Introductions:** Commissioner Markstrom called the meeting to order at 3:00 p.m.
- 2) **Approval of Agenda:** Commissioner Shaffley made a motion to approve the amended April 17, 2024, agenda as submitted. Commissioner Lahmann seconded the motion. The motion carried.
- 3) **Good of the Order/Public Comment:** Commissioner Markstrom opened the meeting to public comment and stated the rules regarding public comment.

  - a) **I-5/Mellen Street Connector Project – Stage 1 – Pay Request #14:** Commissioner Shaffley made a motion to approve Pay Request #14 in the amount of \$225,006.49 to Midway Underground for Stage 1 of the I-5/Mellen Street Connector project. Commissioner Lahmann seconded the motion. The motion carried.

- b) **Landlord Consent – 3712 Steelhammer Lane:** Commissioner Shaffley made a motion to approve the Landlord Consent for Viasat to install an antenna at 3712 Steelhammer Lane. Commissioner Lahmann seconded the motion. The motion carried.

- c) **2023 Financial Statements:** Kyle Heaton gave a brief overview of the 2023 Financial Statements. He commended Amy Graber’s work on the financial statements. He also provided the Commissioners with a first quarter budget status report.
