- 1) **Call Meeting to Order/Introductions:** Commissioner Markstrom called the meeting to order at 3:00 p.m.
- 2) **Approval of Agenda:** Commissioner Shaffley made a motion to approve the November 5, 2025, agenda as amended. Commissioner Lahmann seconded the motion. The motion carried.
- 3) **Good of the Order/Public Comment:** Commissioner Markstrom opened the meeting to public comment and stated the rules regarding public comment.

Scott Tennant, of Chehalis, commented on the responsibility of curtailing public comment.

Gary Odegaard, of Centralia, commented on the City of Centralia development moratorium and transparency.

Paul Crowner, of Centralia, commented on the budget.

Jan Banevich, of Centralia, declined to comment.

Brian Dow, of Centralia, commented on transparency and public participation.

Cynthia Mudge, executive director of the Centralia-Chehalis Chamber of Commerce, commented on an upcoming Chamber event.
- 4) **Approval of Minutes:** Commissioner Lahmann requested a correction in the Commissioner Report section.

Commissioner Lahmann made a motion to approve the corrected October 15, 2025, regular meeting minutes as stated. Commissioner Shaffley seconded the motion. The motion carried.

5) **Approval of Warrants:** Commissioner Lahmann made a motion to approve warrants 24611 through 24646 with an aggregate amount of \$294,786.35. Commissioner Shaffley seconded the motion. The motion carried.

6) **New Business:**

a) **Executive Director Report:** There was no Executive Director report made.

b) **Commissioner Reports:** Commissioner Shaffley congratulated Ally Pickard for winning the election.

Commissioner Lahmann commented that it was time for the Executive Director's annual review. Commissioner Markstrom replied that it would be on the agenda for the next meeting. Commissioner Lahmann commented that he asked for a list of Port businesses and addresses and requested to meet the Port's lobbyist. He reported that he attended a Centralia City council meeting, a Lewis County Board of County Commissioners meeting, and a Southwest Washington Regional Transportation Council meeting.
